- Q4 By refering to the Valuers, Appraisers, Estate Agents and Property Managers Act 1981 (as amended), explain the followings with examples.
 - (a) A registered valuer or appraiser who acts as an estate agent to a transaction should not subsequently value the same property for the same purchaser.

(b) No registered valuer, appraiser or estate agent shall, directly or indirectly, allow or agree to allow participation by any person or company, other than a registered valuer, appraiser or estate agent in the profits of his professionals work.

(c) It is a duty of a registered estate agent to protect the public against fraud, misrepresentation and unethical practises in respect to all real estate transactions.

Q5 The Malaysian Valuation Standards, under Standard 9 stated, "The Valuation Report must provide sufficient information to permit those who read and rely upon the report understand its data, reasoning, analysis and conclusions. It must state any assumptions and limiting conditions upon which the valuation is based."

Based on the statement above, write an actual complete report for a double storey terraced house located in Lot 1286, Taman Universiti 6, Parit Raja, Batu Pahat, Johor for mortgage purpose. Your report should follow the format and contents as outline by Standard 9, The Malaysian Valuation Standards. You should include any assumptions, sales comparison and justifications to arrive the Market Value.
