Q1 (a) In 2018, Strategic Facilities Management Framework Royal Institute of Chartered Surveyors (RICS): Global Guidance Notes was published by the Royal Institution of Chartered Surveyors (RICS) and International Facility Management Association (IFMA). The IFMA-RICS Collaboration in publishing this document represents a significant chapter in the history of facility management (FM), providing an unprecedented level of industry support to meet the growing demands of FM practitioners worldwide.

(c) World energy consumption continues to rise. It has more than doubled in the last 40 years and is projected to increase a further 30 % by 2040. Certification to the ISO50001 standard by an independent auditor is not a compulsory measure. To certify or not is a decision to be taken by the organization, unless imposed by regulation.

Q2 (a) A novel infection, new and previously unconfronted that spreads globally and results in a high incidence of morbidity (sickness) and mortality (death) has, for the past 300 years or more, been described as a pandemic. The word derives from pan "across" and demos, meaning "people" or "population".

(b) "When you step outside your door, your actions in the physical world are swept into the dragnet. The government gathers an enormous collection of information through the video cameras placed on your street and all over your city. If you commit a crime or simply jaywalk facial recognition algorithms will match video footage of your face to your photo in a national ID database. It would not be long before the police show up at your door..." (The Atlantic, 2020).

China is embracing technologies like facial recognition and artificial intelligence to identify and track 1.4 billion people. The concept of "Nothing to hide, nothing to fear" (NTHNTF) involved a vast network of digital espionage as a means of social control, creating a dystopian society in China.

Debate **POSITIVE** and **NEGATIVE** implications of NTHNHF digital surveillance technology in the midst of coronavirus (COVID-19) to the citizens of China.

(c) In London, since the coronavirus outbreak, East London's ExCeL exhibition centre, which normally plays host to lifestyle shows, expos and conferences, was converted into the temporary NHS Nightingale hospital, with a space for 4,000 beds. The ExCeL centre's suitability for the hospital site goes beyond the functional characteristics of the building. In Malaysia, MARDI's Agro Exposition Park Serdang (MAEPS) was converted into a quarantine centre with a capacity of 600 beds in a short period of time to accommodate a new wave of coronavirus patients.
