The Director decided to expand the business with the opening of new branch in Melaka. You are currently performing a monitoring and controlling project activity, and you have discovered that some of the project works have not been performed according to the plan. A sudden change of the top management changes the direction of the company. In addition, a special tool is needed to check the vulnerabilities of the network. It is expensive and requires an expert to handle the tool. Since the network consultant leave the company, there is nobody that can be trusted to handle the tool. Then, it being reported that there are some issues in handling data being shared and transferred within the business. They are not yet checked to comply with Health Insurance Portability and Accountability Act of 1996 (HIPAA). With a very tight budget, you need to fix the problem. In additional to the current issue, one of the key stakeholders make a change request to one of the modules in the project. The request is regarding a module that is not in the original specification but if it not being addressed, the network will leave with an open hole for attacks.
