 - (a) Explain the following terms to her in ensuring the monthly claim can be prepared accurately:
 - (i) Advanced Payment Bond
 - (ii) Interim Payment
 - (iii) Material on site
 - (iv) Provisional Sum
 - (v) Prime Cost Sum
