Q1 (a) Explain the situation under which a person may be liable for the act of the firm when in fact, he is not a partner. Kindly refer to the relevant provision of law and a decided case.

(b) Mr. A, Mr. B, and Mr. C are partners in a firm carrying on a bus transportation business. One day Mr. A involve in an accident when he accidentally injured a bystander beside the road named Mr. Abu. The firm's bus was also damaged. Mr. A borrowed RM2,000 from Mr. Sabu to repair the bus as the firm had no money at that time but without informing other partners about the loan. A week after that, Mr. B was charged under Anti Money Laundering and Anti-Terrorism Financing Act 2001 ("AMLA") for his involvement in the gangster group in Johor Bahru.

Analyse the liability of the partners of the firm as follows:

(i) The liability of the partners to Mr. Abu;

- (b) Decide the following scenario based on the Sale of Goods Act 1957.
  - (i) Wawa ordered a brand-new car "Mezda BMX-9" model, from an authorized car dealer in Batu Pahat. She relied on the specification given by the car dealer at the time of negotiation. However, when delivered, it was found that the car was another model of "Mezda BMX-8". Being dissatisfied with the car delivered, Wawa was poised to take legal action against the car dealer.

Advise Wawa on her rights under the relevant laws.

(ii) Jenny agreed to sell her handbag to Jessi for RM1000. The advertisement and negotiation were made on Jenny's Instagram. Soon after the payment had been made, Jenny delivered the handbag to another person called Wati. Jessi felt victimized and took legal action against Wati to claim the handbag. Meanwhile, Wati contended that she was unaware of Jenny and Jessi's previous transaction.

Advise Jessi on her rights under the relevant laws.
