

In November 2020, MACC had hauled 28 immigration officers and personnel in Selangor and Johor after they were alleged to have been involved in an activity of misusing the stamp at the country's borders.

A source at the time told Kosmo that an immigration staff of Grade 19 earning less than RM4,000 a month was in possession of several luxury cars, including a Rolls-Royce Phantom, Ford Mustang, Range Rover, and an Audi, which were all registered under the names of two foreign worker agents from China. The report stated that the vehicles were given as a reward for helping set up a counter for the agents at the border.
