Q7 BusinessMy Sdn. Bhd. has been suffering from increased security breaches for the last few years and is considering investing in a user behavior analytics (UBA) solution. ABC's CIO estimates that ABC has been suffering about 10 (Annual Rate of Occurrence (ARO) =10) security incidents per year for the last three years. These incidents seem to cost about \$22,000 (Single Loss Expectancy (SLE) =22,000) in data loss, fine, and productivity. The UBA solution is projected to block about 90% (mitigation ratio = 90%) of the attacks. However, the cost for the solution is estimated at \$60,000 per year.
